# HEALTHY CHOICES

**Presented by**  
**Dr. Stephen Prescott**  
**President, OMRF**

## **About our presenter:**

Stephen Prescott, MD, joined the Oklahoma Medical Research Foundation in 2006, becoming OMRF's ninth president since OMRF was chartered in 1946. A leader in studies of the basic mechanisms of human disease, Prescott came to OMRF from the University of Utah, where he founded the Eccles Program in Human and Molecular Biology & Genetics and served as the executive director of the Huntsman Cancer Institute, an NCI-designated cancer center.

At OMRF, Prescott has led and raised more than \$90 million to fund the largest campus expansion in the foundation's history. The centerpiece of this growth is OMRF's research tower, a 186,000-square-foot facility that has earned gold-level LEED certification. In the tower, physicians in OMRF's Multiple Sclerosis Center of Excellence treat more than 2,000 MS patients while exploring new avenues of clinical research. The MS Center is part of OMRF's Autoimmune Disease Institute, recognized by the National Institutes of Health as one of only seven Autoimmunity Centers of Excellence in the U.S. Under Prescott's leadership, OMRF has earned eight consecutive four-star ratings—the highest possible—from Charity Navigator, the nation's leading nonprofit evaluator. During this time, *The Scientist* magazine has also named OMRF as one of its "Best Places

to Work" in academia and for post-doctoral fellows for three straight years.

A native of Texas and an undergraduate at Texas A&M University, Prescott received his MD from the Baylor College of Medicine prior to completing his training in internal medicine at the University of Utah. After advanced research training at Washington University School of Medicine (St. Louis), he joined the faculty of the University of Utah, where he became a professor of internal medicine and held the H.A. & Edna Benning Presidential Endowed Chair. He has authored more than 250 scientific articles and has trained more than 40 research students and postdoctoral fellows.

Prescott served as a senior editor of the *Journal of Biological Chemistry* and *Journal of Clinical Investigation* and on advisory committees for the National Institutes of Health, the American Heart Association, the American Cancer Society, and multiple universities. He has been elected to the American Association for the Advancement of Science, the Association of American Physicians, the American Society for Clinical Investigation, the Royal College of Physicians in Ireland, and the Royal Academy of Medicine in Spain. He has received numerous scientific awards, consulted for and served on the boards of numerous pharmaceutical and biotechnology companies in the U.S. and abroad, and is the founder of LineaGen, a biotechnology company.

# PROGRAM OVERVIEW:

Everyone will either need a doctor at some point or, at the very least, will benefit from the research that provides for healing medications. Dr. Prescott will explain the ethical basis for those pesky privacy laws giving headaches for HR pros, then discussing the big-picture ethical issues affecting physicians duties to their patients.

1. The ethical, legal, and regulatory imperative to maintain the privacy of health information.
2. The ethical and legal basis for consent-to-treat, and the differences for clinical research (analogy to private property rights).
3. The ethical basis for prohibiting physicians from participating in lethal injection (death penalty) and assisted suicide.

Respect for individuals is a cornerstone of nearly all ethical theories. Understanding that concept makes it easier to understand the privacy requirements behind the HIPAA laws. This can be a tricky area and the answers below do not constitute a legal opinion. It is always better to seek more indepth answers from your company's legal counsel before proceeding. 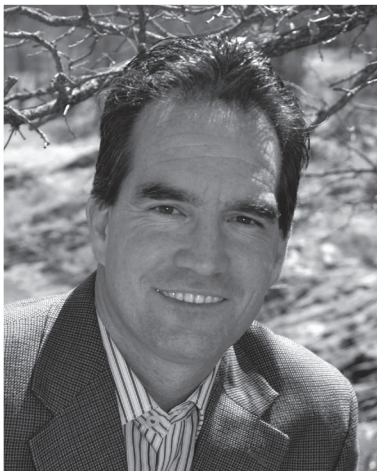

# GUIDING PRINCIPLES

Adopted July, 2004

To ensure that the Consortium fosters positive characteristics of integrity in the successful achievement of its goals, these Guiding Principles were discussed and adopted (with revisions) during a milestone planning session held by Consortium leaders in Stroud on June 18, 2004. These principles were developed based on the Character First's values and philosophies.

## RESPONSIBILITY TO SELF AND OTHERS

### Service

- Passion for promoting ethics and integrity
- Encouraging the promotion of ethical behavior through personal actions and
- Sharing ideas and resources
- Responsibility and accountability for fulfilling the mission of the Consortium.

### Collaboration

- Achievement of common goals through the promotion of ethical, mutually beneficial relationships
- Service to the Consortium over promotion of self-interest
- Cooperation emphasized over competition in promoting ethical business conduct
- Members collaborate by being constructively engaged in discussions regarding ethics
- Seeking consensus in interactive discussions regarding ethical matters.

### Respect

- Members may become aware of confidential information shared by others in an effort to determine an ethical course of action. We ask members to be sensitive in recognizing and respecting the efforts made toward achieving ethical behavior. In that vein, public disclosure of this information is discouraged.
- We respect other members and the process by:
  - Exhibiting listening skills and actively listening to discussions
  - Being open to other points of view and outcomes
- We are an inclusive organization and demonstrate this by welcoming members who are in different stages of learning as applied to ethical behavior.

- Members are asked to demonstrate their support of this initiative by consistently attending meetings.

### Initiative

# OK ETHICS 2014-2015 MEMBERSHIP DUES & BENEFITS

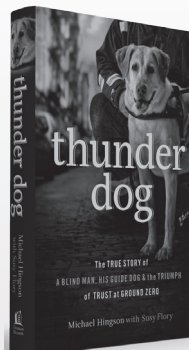
